## **Part 2: Description**

Educational aims: This module aims to examine what Stalinism entailed in practice

and theory.

**Outline syllabus:** The most significant aspects of Soviet Political, SocioEconomic and Cultural History from the death of Lenin in 1924 to the death of Stalin in 1953 will

be investigated. It will also discuss the historical debates surrounding the above. Areas covered include: Stalin's early years; Stalin and the October Revolution; the struggle for succession and NEP, collectivisation and industrialisation, the Cultural Revolution; retreat and consolidation during the 1930s; the cult of the personality; the Great Terror; the Great Patriotic Struggle; post-war reconstruction; the Zhdanovshchina; Stalin's last years; Stalinism in Eastern Europe; Stalinism in China.

## Part 3: Teaching and learning methods

**Teaching and learning methods:** Teaching will normally comprise one two-hour seminar and one one-hour virtual synchronous activity per week.

Seminar preparation should normally consist of an average of 4 hours independent study time based upon essential and indicative reading as specified in module handbooks.

Scheduled learning includes lectures, seminars, tutorials, project supervision, demonstration, practical classes and workshops; fieldwork; external visits; work based learning; supervised time in studio/workshop.

Study time for the module is composed of 72 hours of contact time. This will normally be in the form of 3 hours per week contact time composed of a two-hour workshop and a one-hour virtual synchronous activity per week.
