Assessment Strategy	The assessment strategy for this module is in the form of a portfolio of co work.			
	The summative assessment is work that allows the student to present the design and execution of a primary or secondary research and study or service evaluation that they have undertaken. The dissertation portfolio should not exceed a maximum of 10,000 words (excluding reference lists) and consists of:			

1. A journal article prepared for submission to a journal of their choice (70%).
2. An explanation and justification of the academic journal the paper is (hypothetically) written for (5%)
3. A reflection on their research. This will provide students space to justify their decisions in carrying out the research and in evaluation that might not fit well in the journal article (10%).

Formative assessment occurs throughout the module as the student works with the allocated dissertation supervisor.

Additionally students will be required to deliver a poster presentation of their research (15%)
