Educational aims: This module aims to provide students with a comprehensive introduction to criminal psychology and the role that psychology plays in the criminal justice system (CJS). This will be done by examining offender motivations and the range background characteristics that can influence offending behaviours, as well as

societal responses to offenders in terms of punishment and treatment. Students will be able to apply this knowledge to real life situations by developing an offender profile of a known serial killer.

Outline syllabus: Whilst the specific lecture programme may vary year to year to reflect current issues, legislative changes and research developments, the main topics that will be covered by the module would likely include:

The social construction of violent and/or dangerous offenders

Psychological theories of crime (biological, developmental, psychodynamic and social)

Psychology and the CJS (including offender profiling, eyewitness testimony, police decisionmaking and interviewing, and psychology in the courtroom)

An examination of different types of offenders and forms of offending (including stalkers, serial killers, sexual offending and domestic violence and abuse)

An overview of issues of treatment, risk management, reoffending and rehabilitation

Part 3: Teaching and learning methods

Teaching and learning methods: Contact Hours:

The module is based on a combination of lectures and seminars equating to a minimum of 72 hours over 24 weeks

Module Learning outcomes: On successful completion of this module students will achieve the following learning outcomes.

MO2 Identify and evaluate a range of psychological theories of crime

MO3 Recognise and critically discuss key debates regarding the role of psychology in the criminal justice system

MO4 Develop and present a critical analysis profiling the psychology of offenders and identifies appropriate forms of treatment for them

Part 4: Assessment

Assessment strategy: This module includes both formative and summative forms of assessment. Students are provided with feedback on their first assessment (a case study) which can then be reflected upon and used to inform their second assessment (a viva). In both assessments, students must draw upon a wide range of issues covered throughout the module.

One 3,000 word case study profiling a selected serial killer (70%) (Learning outcomes 1, 2, 3, 4, 5).

One 15 minute viva based upon their case study (30%) (Learning outcomes 1, 2, 3, 4, 5).

The assessment strategy for this module was selected in order to contribute to the development of key Level 2 skills and module learning outcomes, and to contribute to the diversity of assessment methods on the programme as a whole. The module

adheres to the UWE Academic Regulations and Assessment Cycle Policy, and assessment and feedback will form a critical aspect of the students learning process in line with UWE's Assessment Cycle Policy and will follow UWE's inclusivity guidance.
