Before starting placement you will attend the relevant placement induction for lead lectures/seminars and/or simulation and skills workshops (2-5 days dependent on organisation).

Whilst on placement you will spend equivalent of 2 days (14 hours) self-directed learning with your peers on developing a patient safety presentation and other study. Throughout the course you will spend 6 days (42 hours) at the university for lead lectures/seminars.

# Part 4: Assessment

**Assessment strategy:** The assessment for the module involves the development of a professional portfolio and a written assignment.

Professional portfolio; a competency framework (Ongoing Achievement Record) that is assessed in practice to ensure students meet the nine outcomes required to return to practice. Students will also be required to complete a Numeracy Multiple Choice Questionnaire (MCQ). Students are required to achieve a minimum percentage in the MCQ in order to demonstrate safe practice in Medications Administration.

Each student will have a formative assessment of their progress at the midpoint of their return to practice. The final summative assessment takes place at the end of the module.

Written assignment (2000 words); a reflection which focuses on at least two of the 6Cs of nursing (communication, compassion, commitment, courage, competence and care). These may be very specific but in turn should relate to at least one of the competencies for returning to practice from the Ongoing Achievement Record. The chosen areas for reflection should enable you to; demonstrate application of your knowledge and to analyse the evidence, to include discussion about how this
