The module focuses on experiential learning in the context of events and provides you with the opportunity to learn about relevant theory that you will apply to practice to critically reflect on your experience within the events industry as well as practical sessions that focus on your professional development.

You will develop a critical understanding of the notion of an events professional and reflective events practitioner.

You will use the UWE Career Management Framework to conduct a personal and skills audit and develop a personal development plan in advance of gaining work experience within the events industry where you will work towards the development objectives that you identify. You will also work on your career goals with consideration of your continuing professional development.

You will learn how to enhance your employability through analysing the labour market, developing your personal brand, enhancing your curriculum vitae, writing job applications, building resilience, preparing for interviews and how to network and prospect to develop your social capital.
