Teaching and Learning Methods	Scheduled learning includes lectures, work related learning experiences, seminars, tutorials, workshops and shared presentations. Independent learning includes hours engaged with essential reading, case study preparation, assignment preparation and completion etc. These sessions constitute an average time per level as indicated in the table below. Work related learning: This will comprise of a range of work related learning experiences within performing and visual arts organisations working in education and learning contexts, Specific work related learning contexts organised through student facilitation in negotiation with the module leader.		
Reading Strategy*	It is essential that students read one of the many texts on research methods available through the Library. Module guides will also reflect the range of reading to be carried out. Further Reading Students are expected to identify all other reading relevant to their chosen research topic for themselves. They will be encouraged to read widely using the library catalogue, a variety of bibliographic and full text databases, and Internet resources. Many resources can be accessed remotely. Access and Skills The development of literature searching skills is supported by a Library seminar provided within the first semester and by the Graduate Development Programme at level three. These level three skills will build upon skills gained by the student whilst studying at levels one and two. Additional support is available through the Library Services web pages, including interactive tutorials on finding books and journals, evaluating information and referencing. Sign up workshops are also offered by the Library.
