Learning Outcomes	<p>On successful completion of this module students will be able to:</p> <ol style="list-style-type: none"> <li>1 Design, implement and critically evaluate a seasonal coaching plan for advanced performers whilst appraising the applicability of known models to a distinct context. (A and B)</li> <li>2 Incorporate into their planning the results of performance analysis techniques and player profiling, whilst demonstrating knowledge of accepted models of paper-based and computerised applications and understanding their applicability to personal coaching philosophies and professional playing demands. (A and B)</li> <li>3 Appraise critically the performance development environment within which the coach and players operate, demonstrating critical awareness of and contingency planning for potential obstacles to high performance amongst individual players, team sub-units and organisational support structures. (A and B)</li> <li>4 Demonstrate knowledge and understanding of key athlete (and support staff) safety and performance enhancing protocols from the strength and conditioning domain. (A and B)</li> <li>5 Prepare, manage and reflect upon player feedback protocols (both verbal and written) targeted towards individuals, small groups, whole squads and related support staff. Teaching and Learning Methods	<p><b><i>Scheduled Learning</i></b></p> <ol style="list-style-type: none"> <li>1 The module and its method of assessment will be introduced via a three day residential seminar series that combines lectures, practical demonstrations and tasks, reflective group-work and evidence collection (for an over-arching portfolio), guest speakers and one-to-one assignment support.</li> <li>2 All candidates will receive three visits from both an Assessment Support Tutor (from UWE Hartpury) and an RFU appointed Coach Advisor during which assignment refinement and directed coaching tasks will be completed.</li> <li>3 Post-seminar directed study will highlight key research sources, methodologies and potential approaches to assignment completion whilst broadening the candidates' awareness of the pertinent field of study.</li> </ol>

	<p><b><i>Independent Learning</i></b></p> <ol style="list-style-type: none"> <li>1 The introductory seminar will be preceded by a reading and research task outlining key ideas and sources upon which the module will be founded and against which the candidates will be asked to compare their current knowledge, understanding and practice.</li> <li>2 Assignment completion will be supported by further online / telephone tutorials from the Assessment Support Tutor and by access to a dedicated Blackboard presence. Given their professional backgrounds and the need for a course that demonstrates 'postgraduateness' the candidates will also be encouraged to form virtual and geographic study support groups to further their development of understanding and transferable skills.</li> </ol> <p><b><i>Blackboard (or equivalent)</i></b></p> <p>This module is supported by Blackboard where students will be able to find all necessary module information. Direct links to information sources will also be provided from within Blackboard (or equivalent).</p>
Reading Strategy	<p>All candidates will complete an Individual Learning Plan (Shell Framework) alongside the Assessment Support Tutor and this exercise will allow both a needs analysis for future academic support and an opportunity to flag up the full range of hard copy and online resources available to them.</p> <p><b><i>Essential Reading</i></b></p> <p>Core material will be indicated to the student via pre-course material, module guides and through their accessing a dedicated Blackboard programme presence. No requirement for the purchase of set text(s) will be made and students will have full access to UWE Hartpury library services, online applications, and inter-library loans. The input of a dedicated Assessment Support Tutor will supplement the normal provision expected at M-level so that research sources and relevant texts will be identified to the student and issues revolving around their access to them resolved.</p> <p><b><i>Further Reading</i></b></p> <p>Students are expected to identify all other reading relevant to their chosen topic for themselves. They will be required to read widely using the library catalogue, a variety of bibliographic and full text databases, and Internet resources. Many resources can be accessed remotely. The purpose of this further reading is to ensure students are familiar with current research, classic works and material specific to their interests from the academic literature, wider professional sources and in-house publications of the Rugby Football Union.</p> <p><b><i>Access and Skills</i></b></p> <p>The development of literature searching skills is supported by a Library seminar provided within the first semester during the initial Individual Learning Plan negotiation. Students will be presented with further opportunities within the curriculum to develop their information retrieval and evaluation skills in order to identify such resources effectively. Additional support is available through the Library Services web pages, including interactive tutorials on finding books and journals, evaluating information and referencing. Sign up workshops are also offered by the Library and the Assessment Support Tutor will be available for online and telephone based information, advice and trouble-shooting.</p>

<b>Part 3: Assessment</b>	
Assessment Strategy	<p>Summative assessment centres upon:</p> <ol style="list-style-type: none"> <li>A A 15 minute controlled conditions presentation that demands further reflection upon theory to practice links within the knowledge domain represented by the module, whilst the candidate is also asked to demonstrate postgraduate intellectual skills by evaluating both their personal and professional development in light of their learning experience.</li> <li>B A written assignment with two distinct sections in order to balance depth and breadth of each candidate's application of knowledge whilst allowing them an evaluative contrast between the 'scientific' mode (season long strength and conditioning plan) and the 'philosophical' mode (ethics in the management of injury). This contrast supports the development of transferable skills by asking candidates to write with distinct audiences in mind whilst necessarily relating theoretical content to their own distinct coaching practice. A 2,500 word count asks for effective choices in research sources and the demonstration of concise writing skills. The assignment format – a scientific report with appropriate diagrammatic content – contrasts with written work from other modules and allows further professional/transferable skills to be demonstrated.</li> </ol> <p>Formative assessment similarly has two components:</p> <ol style="list-style-type: none"> <li>1 Group discussion and individual reflection is demanded by tasks set within the introductory three day seminar.</li> <li>2 RFU Coach Advisor visits will include assessment of candidates' use, evaluation and refinement of theoretical material contained in the module via formal observation of coach practice and one-to-one developmental discussions.</li> </ol>
