Part 2: Description

Educational Aims: This module concentrates on the role of Contracts Administrator as performed under JCT contracts and explores how the obligations of various parties are defined and interpreted especially when subject to legal precedent established in case law.

Various forms of contract are acknowledged as are the reasons behind the selection of specific procurement routes that require them.

Part 3: Assessment

The assessment strategy for the module is made up of two components:

Component A

An end of semester 24 hour "take home" online assessment which will provide a suitable, rigorous and effective mechanism for measuring how effectively the students have attained the learning outcomes.

Exam to be 2 hours equivalent in duration with 3 questions to be attempted from a bank of 5 seen questions. 1 of the 5 questions to be compulsory the other 2 to students choice.

Component B

A 1500 word essay covering a number of core elements from the learning outcomes. A specific scenario relating to a construction contract will be given where the student will be required to apply what they have learnt about contract law and precedent. This may include needing to recognise and appraise matters relating to disputes and procedures and/or dispute resolution.
