Reading Strategy

Assessment Strategy	<p>Summative assessment includes a CV, covering letter and application form assignment to help prepare students for the application process for placement opportunities within a veterinary practice at the end of their first year. Development of communication skills prior to placement is also important and so the process of preparing for and engaging in an oral examination (under controlled conditions, in a high pressure environment) is considered beneficial.</p> <p>Formative assessment is available throughout the module including feedback during a mock interview practice and opportunities to discuss good practice in writing covering letters, CV's and application forms.</p> <p>In line with the College's commitment to facilitating equal opportunities, a student may apply for alternative means of assessment if appropriate.
