Part 2: Description

Overview: This module provides students with the understanding of age demographics and the effects of an aging population in relation to healthcare. Students learn a variety of medical conditions specifically affecting older person care including dementia, palliative care support and safeguarding concerns. As well as this, students explore their learning and understanding on falls, effective communication skills, pharmacology, and polypharmacy; all vital to provide and deliver excellent patient care in a paramedic setting.

Students are also given access to bespoke, interactive learning resources for the module, containing audios, games and quizzes giving opportunities to develop knowledge and understanding as they progress through the module.
