Part 3: Teaching and learning methods

Teaching and learning methods: This module will consist of an introductory lecture prior to commencement of the placement year so that students have a good understanding of the requirements of the module, the resources available, the relationships between the employer, the university and the student and the information systems that will be utilised. As the module will be undertaken whilst on placement or in the workplace (if on the part time routeway) the module will be supported by learning objects and the libraries research skills resources.

The module will be structured and materials provided to enable the students to become autonomous learners. Kaltura videos will support the module enabling students to engage with the materials on demand. Sessions will be delivered to help the students identify suitable individual studies, development of their study, researching library and company databases, presenting their work and development of their final report.

Students will be assigned both an academic tutor and a workbased mentor. The role of the latter will be to provide support to the student regarding the choice of topic and its relevance to the workplace experience and to advise regarding workplace sources of information, data and their confidentiality and to authenticate that the work undertaken is that of the student.

Part 4: Assessment

Assessment strategy: The assessment strategy has been designed to support the student in developing good practice approaches to an extended individual piece of work.

A 'portfolio' of formative submissions will support developmental milestones. For some of these submissions the workbased mentor will sign approval to ensure the appropriateness of the chosen study to the workplace environment and experience in terms of confidentiality, accessibility of information and timeframe.

Formative submissions will facilitate the student to enable them to introduce their individual study, identify the issues, sources of information, research methodology and ethical checklist. These tasks will be submitted in semester one and encourage the student to adopt good research skills to support the individual study work.

The Assessment:

Reflective Piece - Competency log. the student will also be required to reflect on their workplace experience in the context of their individual professional field and also reflect on their individual personal development using the competency frameworks of their chosen profession. The student will also be expected to register their placement activity on the UWE Future Awards website. This section of the report will also include a Mentor's Report that assesses the student's workbased skills on a threshold basis. A satisfactory Mentor's Report provides evidence of engagement in the placement year in a professional capacity and will signify a 'SW' routeway on the student's record regardless of whether they passed the module.

Report - The written report provides evidence that the student can produce a critical analytical study relating the underpinning body of knowledge to their chosen study, supported by appropriate evidence in order to draw substantiated recommendations. The mentor will authenticate the report.

Written Assignment - The description of the project will be assessed by a powerpoint presentation with imbedded audio so the student can make the most effective use of project information. It will also support the development of communications skills which are an essential element of an individual's personal development.

Resit Reflective Piece - a similar brief to that described above.
