Students will complete a critical reflective account of their professional practice area, focusing on the implementation of a service / practice development or initiative in relation to one of the following;

- Ethical issues
- Risk taking
- Relationships
- Psycho social aspects
- Stress and distress

At level M students are expected to critically evaluate, synthesise and provide independent perspectives regarding the delivery of service in this case study. This should include a critical exploration of the literature and debate the wider socio-political implications of dementia care.
