### Part 3: Teaching and learning methods

**Teaching and learning methods:** This module is only available to students of interior architecture at UWE who are spending one year abroad on Erasmus exchange. Students will follow a suite of modules on offer at the host university to enable them to achieve the outcomes listed above. Partner universities have been carefully chosen so as to be able to offer the required learning and the required credits. The modules followed abroad must be approved by UWE staff in advance of the exchange taking place.

Once abroad students study in the surroundings of the host university and are tutored by staff of that institution. Staff at UWE are also available (via internet etc...) for support.

Scheduled learning includes studio, lectures, tutorials, workshop, site visits.

Independent learning includes hours engaged with essential reading, case study preparation, assignment preparation and completion etc.

These sessions constitute an average time per level. Scheduled sessions may vary slightly depending on the module choices you make.
