Practical revision sessions on placement related specialities such as Cardiorespiratory, Neurology, Musculoskeletal, Orthopaedics and Paediatrics.

Optional practical sessions, e.g. Gait and Walking Aids.

Practice:

Practice placement level 3a and level 3b. Each placement consists of 5 weeks of professional practice in a variety of environments and health care settings. Setting of individual personal goals relevant to practice and student's individual learning need.

Teaching and learning methods: Two 5 week placements in different settings plus 8 hours teaching to usually include 2 hours of lectures and 6 hours of seminars/practical's prior to placement 3a.

Assessment strategy: This is the final professional practice module which consists of two 5 week placement blocks. The assessments for this module will be based on the students' clinical performance against the module learning outcomes.

The module has four assessment tasks; a pass/fail continuous practice assessment for each placement block and a graded assessment for each placement block.

Each graded assessment comprises a number of competency based assessments;

students must achieve a mark of 40% or above in each to demonstrate the required level of professional competency to pass.
