# Part 3: Teaching and learning methods

# Teaching and learning methods: Scheduled learning:

This will include lectures, seminars, and debate. There will be a "flipped classroom" approach to the face-to-face sessions. Students will be provided with baseline information/reading/video capture pertaining to a particular topic area in the week leading up to the session. The lecture/workshop/debate will focus on specific questions that have been drawn from the baseline information.

# Independent learning:

Students will be expected to engage in substantial and focused independent work in this module. This will potentially include hours engaged with: essential reading, assignment preparation and completion. Student cohorts will also be provided with a virtual meeting space that they will be able to fully utilise independently for the purposes of peer-support, collaboration and discussion, in order to foster a sense of a learning community.

#### TEL:

The university supported learning portal and virtual learning environment, will be used to support students' learning, conduct activities, organise and communicate learning materials. Students will be able to engage with the material, other students and members of staff through these systems and make use of the various functionalities built into them (e.g., blogs, journals, audio, video, discussion boards, wikis, etc.) as appropriate and useful for the module learning. A culture of continuous learning will be developed through the implementation of regular on-line discussion groups which discuss identified topics in-depth.

### Part 4: Assessment

Assessment strategy: The Assessment Strategy has been designed to support and enhance the development of both subject-based and employability skills, whilst ensuring that the modules Learning Outcomes are attained, as described below. Assessments are designed to underpin students' learning and skills acquisition in the module and to provide for learning beyond the material delivered in the classroom.

Assessment One: A group psycho-educational presentation was selected to assess the students understanding of sport and/or exercise psychology theory and the practical application of this. The presentation brief will ask them to deliver to a hypothetical audience of sport or exercise professionals (e.g. coaches, physiotherapists, exercise instructors) for 20minutes.

Module Specification

Assessment two is a 1500 word critical literature review. Which requires students to:

Select an area of either sport or exercise psychology. Students are deliberately offered a degree of autonomy in this respect.

Carry out a literature review of that area.

Critically identify a gap in the literature as a result of the review.

Formulate a research question that addresses the gap.
