Online submission of 1500 written assignment. The learning outcomes include the NMC requirements for the practice supervisor role so that on completion of the module students will be able to undertake this role on registration.

Component A

A critically reflective essay with supplemental lesson plan. The first part of the essay will reflect on a teaching and learning experience in practice placement, and appraise the teaching and learning methods and approaches. The second part of the essay involves the design of a future teaching and learning event as a practice supervisor supported with a lesson plan, and demonstrating rationale behind teaching and learning methods and approaches.
