Part 2: Description
<p>This module will explore ideas, thought and myths in its historical and contemporary contexts, and introduce students to key theoretical approaches to the analysis of texts.</p> <p>Teaching sessions will introduce students to a range of thinking about Arts and Humanities through time. <ul style="list-style-type: none"> • Key debates in the Arts and Humanities, and how the Arts and Humanities have been understood over time • The relationships between the Arts and Humanities, the Sciences and the interdisciplinary 'spaces' between these disciplinary traditions. <p>The module is designed to help students understand the expectations of study in higher education and to introduce them to the academic and study skills required for success on their chosen pathway. The module focuses on the core underpinning skills necessary for the thematic modules and aims to develop capacity and confidence for effective independent learning and academic progression. It also has the aim of building up confidence in each student via weekly activities.</p>
