### Part 3: Assessment

The assessment strategy has been constructed in order to allow the student to utilise the knowledge and skills they will gain through this module, and to build upon their existing knowledge and skills as a healthcare professional working in an appropriate clinical area with children and their families.

Formative assessment will take the form of developing an outline for the case based presentation, and discussing this with peers in the online setting in order to develop the application of theory to practice for the final assessment.

The summative assessment will take the form of an individual presentation of 10 minutes followed by 10 minutes discussion/questions, which will allow the student to explore in further depth identified issues from the presentation. The learner will be expected to be able to defend the management of the child that they present.

The case based presentation will be underpinned with a 1000 word paper which details the evidence base for the management of the child in the case based presentation.
