### **Part 2: Description**

**Overview:** This is a Level 5 research methods module for criminology students, which aims to provide students with an understanding of the principles and skills needed to gather and analyse criminological research data.

Features: Not applicable

**Educational aims:** A key objective of this module is to provide students with hands on experience in the collection and analysis of quantitative and qualitative data.

Outline syllabus: Topics may include some of the following indicative areas:

The research processes, i.e. reviewing literature and ethical considerations

Designing research tools, i.e. interview guides and questionnaires

Media and digital methodologies

Secondary data analysis

Managing and analysing qualitative data

Managing and analysis quantitative data

Methods for data presentation, description, and visualization.

## Part 3: Teaching and learning methods

**Teaching and learning methods:** Weekly workshops will allow students to apply their knowledge from lectures and develop their research skills.

Integral to this module is the use of subject based as well as generic technologies. For instance, students will be introduced to public domain data sources such as the Crime Survey for England and Wales and the statistical software package SPSS which is commonly used in criminological research.

Part 4: Assessment

**Assessment strategy:** The module has a single summative point of assessment in the form of a portfolio. The nature of the portfolio is derived from the learning outcomes of the module in that it encourages students to practice and present methodological skills alongside developing their analytical skills.

This supports the broader programme learning outcomes at this level and helps students to build skills pertinent to study at Level 6.

There will be opportunities through workshops and tutorials for students to receive formative feedback which they can use to inform their summative work. To enable students to evidence learning outcomes and help them engage with contemporaneous issues, their portfolio will include evidence of the completion of at least the following two tasks:

1. A demonstration of a methodological technique relevant to criminology e.g. semi structured interviews, questionnaires, and a reflection of the process of gathering

2. A demonstration of an analytical approach, e.g. Univariate and Bivariate analysis

and/or thematic analysis

The combined word count for the portfolio will be a maximum of 2000 words, depending on the specific tasks set. This flexibility opens up options for the course to deal with topical issues and different methodologies in the assessment. For example, demonstration of quantitative analysis would not necessarily require as much word count as a qualitative analysis. As such guidance on the tasks and associated expectations with regards to marking criteria and word count will be clearly stated in the module handbook ahead of the start of the module.
