methodological approaches that are aligned to this area of criminological research.

example, the proliferation of crime stories in various modes of media content.

Key theoretical contributions to the understanding of media and crime, for example,

the media effects debate.

Topical issues related to this area of enquiry as directed by CMC and other notable

sources, for example media coverage of organised crime.

Part 4: Assessment

Assessment strategy: Students will complete a 3,000-word portfolio. The portfolio

should be on a topic of their choosing, selected from within the module syllabus or

relevant to the syllabus (for example, media representations of sex offenders in the

UK) . The portfolio should comprise two parts:

Part A: An analytical essay discussing the chosen topic with reference to relevant

academic theory (approx. 1500 words)

Part B: An analysis of media content relevant to their chosen topic, demonstrating an

appropriate methodological technique. (approx. 1500 words)

The nature of the portfolio is derived from the learning outcomes of the module in

that it encourages students to practice and present methodological skills alongside

developing their analytical skills. This method of assessment also allows students a

level of flexibility in tailoring the topics of the work to their own interests which is in

line with the development of independent study skills that we would expect students

to begin building at this level of study. This supports the broader programme learning

outcomes at this level and helps students to build skills pertinent to study at Level 6.

There will be opportunities through workshops and informal supervision for students

to receive formative feedback which they can use to inform their summative work.
