<p>Syllabus Outline</p>	<p>This module will assess student's ability to perform at the level of a graduate Physician Associate.</p> <p>It will cover the refinement of person-centred consultation skills including the development of a management plan.</p> <p>This will include history gathering, clinical examination, person-centred communication skills and clinical reasoning as well as ensuring the level of self-awareness and reflection appropriate for professional practice.</p> <p>The module will cover:</p> <ul style="list-style-type: none"> <li>- History gathering, person-centred communication and consultation skills</li> <li>- Physical examination skills</li> <li>- Procedural skills and diagnostics</li> <li>- Mental state assessment</li> <li>- Application of clinical reasoning in the interpretation of clinical findings</li> <li>- Recognition of emergency clinical situations</li> <li>- Professional development</li> <li>- The PA role and how to develop strategies to ask for help</li> <li>- Working effectively in a multi-disciplinary team</li> <li>- Personal responsibility and recognition of professional codes of conduct</li> </ul> <p>Foundations in Physician Associate Practice 1 will focus on the application of the above to general adult medicine. Foundations in Physician Associate Practice 2 will focus on the application of the above to paediatrics, obstetrics and gynaecology, mental health, general surgery, emergency and acute medicine.</p>
<p>Teaching and Learning Methods</p>	<p><b>Scheduled learning</b> is largely skills based practical sessions, it includes lectures, seminars, tutorials, demonstration, simulation, practical classes.</p> <p><b>Independent learning</b> includes hours engaged with essential reading, case study preparation, assessment and placement preparation and completion.</p> <p><b>Placement learning</b> includes a minimum of 135 days engaged in practice (clinical placement).</p>

Reading Strategy	<p>Core reading</p> <p>Any core reading will be indicated clearly, along with the method for accessing it, e.g. students may be required to purchase a set text, be given a print study pack or be referred to texts that are available electronically or in the Library. Module handbooks will also reflect the range of reading to be carried out.</p> <p>Further reading</p> <p>Further reading will be required to supplement the set text and other printed reading. Students are expected to identify all other reading relevant to their chosen topic for themselves. They will be required to read widely using the library search, a variety of bibliographic and full text databases, and Internet resources. Many resources can be accessed remotely. The purpose of this further reading is to ensure students are familiar with current research, classic works and material specific to their interests from the academic literature.</p> <p>Access and skills</p> <p>The development of literature searching skills is supported by a Library seminar provided within the first semester. Students will be presented with further opportunities within the curriculum to develop their information retrieval and evaluation skills in order to identify such resources effectively. Additional support is available through the library web pages, including interactive tutorials on finding books and journals, evaluating information and referencing. Sign up workshops are also offered by the Library.</p>

Assessment Strategy	<p><b>Component A:</b> Portfolio; the portfolio of evidence will include;</p> <ul style="list-style-type: none"> <li>• Competencies/skills</li> <li>• Critical reflections</li> <li>• Evidence of professional hours achieved</li> </ul> <p>A formative feedback opportunity will be provided by a review of the portfolio part way through the module.</p> <p><b>Component B:</b> OSCE; will be comprised of a number of stations over a maximum time of 2 hours</p> <p>OSCEs are used in line with the national examination to assess a broad range of clinical and consultation skills (i.e. physical examination skills, consultation skills, communication skills, procedural skills, data interpretation, and drug initiation skills).</p> <p>Practical skills sessions and formative OSCE's will provide an opportunity for formative feedback through the module.</p>
