Part 2: Description

Overview: This module explores colonialism and empire in English Literature across a long period of history, using postcolonial approaches to analyse the way in which places beyond the horizon have been imagined, represented, and colonised.

Features: Not applicable

Educational aims: This module enhances and refines the understanding of the relationship between literature and colonialism you gained at level 1.

Outline syllabus: The module focuses on two broad areas: on the one hand, the ways in which literary texts written during the period of the British Empire represent and reflect on the structures and ideology of colonialism; on the other hand, how writers from the colonies (or former colonies) use literary texts to reflect the experience of being colonial subjects and to contest the ideology of colonialism. You will study texts from different genres, such as fiction and drama for example, and from a period ranging from the 18th century to the 21st century and from different countries. You will approach these texts using concepts drawn from postcolonial theory.
