Outline syllabus: This module will introduce you to a number of key Victorian texts, taking as its common theme writers' engagement with crucial issues of gender in the period, while also embracing the complexities of Victorian society more widely. You will read some major novels and poems which typically focus on the position of women in nineteenth-century society, the relations between the sexes (especially within courtship and marriage), the aspiration to better one's social status through marriage, and social outcasts such as the fallen woman.

Fiction from different genres within the period will be considered, such as the realist novel and sensation fiction. Poetic genres studied may include the sonnet and dramatic monologue. The texts will be studied in relation to contextual issues such as the woman question, marriage and changes in the divorce law, and the rise of psychology and evolutionary biology. Issues of publication, readership and reception will also be explored as appropriate.

Part 3: Teaching and learning methods

Teaching and learning methods: There will be three hours of contact time per week, used flexibly to include lectures, seminars and workshops as appropriate. Lectures may include audio and visual materials. Seminars and workshops involve the close analysis of primary texts, the application of critical approaches, the discussion of contextual material and oral presentations as appropriate. Teaching takes place in rooms designed for interactive activities including group work.

MO1 Appreciate a variety of Victorian literary genres that engage with contextual issues of gender and society, understanding how the content and form of selected texts of the period explore these key themes

MO2 Undertake close critical analysis of selected British texts of the Victorian period that examine gender and society, paying attention to such matters as voice, focalisation and figurative language
