Part 4: Assessment

Assessment strategy: The assessment strategy for this module is designed to allow a diverse range of students to be able to explore their own current and future practice focusing on an existing and or emerging model of care.

Formative assessment: Students will be given the opportunity to have feedback on an assignment plan to inform the final assessment.

Summative assessment: The assignment is by way of a 2000 word case study of a child or young person diagnosed with a life-limiting condition, who now requires palliative care. This should be a criritcal analysis including defining palliative care, assessment and care planning for the child, young person and family including the psychological impact indicating deficits and recommendations for future nursing delivery. Appropriate literature should be used to support all areas of discussion.
