Outline syllabus: This module supports clinical and non- clinical development in primary care through preceptorship. It is aimed at those new to working in this environment and those who are returning to primary care.

The syllabus will typically include:

Professional Values:

Working autonomously within own scope of practice

Applying evidence based practice to support partnership working and shared decision making with patients and their families

Awareness of own learning and development needs, and support needs

Communication and Interpersonal Skills:

Holistic assessment and care planning through shared decision making Equality and diversity: overcoming barriers to effective access to care and care delivery

Public health and motivational interviewing

Primary Care Practice and Decision Making:

Structure, function and values of primary care

Introduction to managing complexity in long term conditions

Patient safety and risk management

Safeguarding and raising concerns (adults, children and families)

Clinical skills for practice: care of the deteriorating patient; mental health issues related to illness & wellbeing; learning disability assessments; introduction to simple and complex wounds; introduction to infection prevention control; health prevention strategies.

Non-clinical skills for practice: Introduction to population management; introduction to risk management; consultation; autonomous practice; critical events; well-being.
