Part 2: Description

Educational aims: The purpose of the module is to give students a sound understanding of how the criminal courts operate in the disposal of the cases brought before them.

Outline syllabus: The module covers the procedural aspects of criminal litigation, from the investigation of criminal offences and the commencement of proceedings, to the preliminary hearings in the magistrates' courts, the trial of criminal cases summarily and on indictment, and the various routes of appeal available to aggrieved parties.

In addition, it covers the procedural aspects of sentencing and the principal powers of the sentencing courts.

Finally, the module considers the rules and principles which govern the admissibility and the use of evidence in the criminal courts.

The subjects covered on the module are set out in detail in the syllabus provided from time to time by the Bar Standards Board.

Part 3: Teaching and learning methods

Teaching and learning methods: The module is taught via seminars involving for example the discussion of pre-prepared questions and unseen exam-style questions; face-to-face and on line lectures and podcasts; and on line exam-style questions.

Module Learning outcomes: On successful completion of this module students will achieve the following learning outcomes.

MO1 State accurately the essential rules and principles governing the conduct of criminal litigation, the sentencing of offenders, and the admissibility of evidence.

MO2 Apply the essential rules and principles governing the conduct of criminal litigation, the sentencing of offenders, and the admissibility of evidence to factual situations of a type frequently encountered in criminal practice.

MO3 Analyse and evaluate different arguments and solutions which might present themselves in the context of a criminal case and determine the merit attaching to each.

MO4 Analyse and evaluate factual situations and arguments to identify those matters which are likely to be important for the purposes of giving legal advice or reaching final outcome.
