## **Part 2: Description**

Overview: This third-year module is a detailed study of the British Civil Wars and

Interregnum. It begins in 1640 with the election of the Long Parliament.

Features: Not applicable

Educational aims: See Learning Outcomes

Outline syllabus: The module examines the causes of the First Civil War, its conduct, and the reasons for the defeat of Charles I. The module then explores life and politics in the Interregnum, and the reasons for the changes of government in the 1650s. Chronologically, it finishes with the Restoration of Charles II in 1660. The module will be divided into two sections. The first will explore the high political narrative, providing an overview of the period in terms of central government, the military command, and the religious elite. The second section will be a social history of the same period, examining life for people beyond central government in terms of politics (including dissent, plotting and subversion) and religion (conformity and protest). It will include discussion of Interregnum culture, from ballads to portraits, and theatre to music.

## Part 3: Teaching and learning methods

Teaching and learning methods: The lectures will provide a chronological overview in the first term, and a thematic discussion in the second. The first assessment will be a research-focused essay. Seminars will have a strong methodological foundation to prepare students for their assignment. The second assessment will be a source-focused examination in the summer term. This will be augmented by virtual seminar exercises to build confidence in using and analysing complex information.
