Part 2: Description

Overview: This module will introduce learners to investigative interviewing, file building, disclosure, roads policing legislation, public protection, vulnerability and safeguarding.

Features: Not applicable

Educational aims: 1. To develop learners' understanding of public protection legislation, policing the roads, vulnerability, safeguarding, and interviewing.

- 2 . To enable learners to develop their skills in effective, ethical investigative interviewing, building an understanding of the file building and disclosure standards central to successful investigations.
- 3. To provide an opportunity for learners to understand the role of critical evaluation of evidence, handling investigative material appropriately, and how to achieve best evidence in criminal proceedings.

Outline syllabus: This module will provide knowledge and training in fundamental professional practices necessary to understand policing and vulnerability, enabling them to undertake the increasingly complex role of a Constable. The module is aligned to the National Policing Curriculum (NPC, see Policing Skills and Procedures appendix 1), and the module learning outcomes reflect the overarching content of the NPC detailed.

The module will examine the underlying principles of public protection work, including key legislation, theories of crime, vulnerability and victimisation, using models such as THRIVE (Threat, Harm, Risk, Investigation, Vulnerability, Engagement). Learners will explore how to recognise vulnerability, and ensure that victims are able to give best evidence in criminal proceedings.

Learners will explore the major 'strands' of public protection policing, including domestic abuse, sexual offending, child abuse, and modern-day slavery; understanding their role within these serious and complex investigations. The module will equip learners with the skills to safeguard some of the most vulnerable members of society.

The module will cover key legislation, powers and procedures for policing the roads safely, and how serious criminality is linked to the road network.

Learners will develop an understanding of investigative interviewing both witnesses and suspects, and the models and theories that underpin practice. Learners will have an opportunity to develop these skills in simulated interviews, building towards an understanding of effective files for prosecutions, and the importance of disclosure in the criminal justice system.

The module will focus on the ethical approaches and behaviours necessary for

effective policing, challenging any misconceptions they may hold of the role of a

Police Constable in increasingly-complex policing environment. Learners will also

explore the importance of involving a variety of private, public and charitable sector

organisations within their professional practice.

Part 3: Teaching and learning methods

Teaching and learning methods: Students will engage with lectures, group work,

independent study, and the use of real and simulated case studies to understand

current policing methods, and explore ways to improve policing practice. Students

will be given the opportunity to develop their skills through role-play interviews,

encouraging a reflective approach to learning and self-development.

MO1 Analyse how the complex nature of vulnerability, risk, public protection and

radicalisation can be investigated and managed in a variety of different policing

contexts (A).

MO2 Provide an appropriate policing response to high-risk incidents (A).

MO3 Critically evaluate different forms of evidence, how it may direct an

investigation, the impact this has on investigative decision-making, and the

importance of file-building and ethical disclosure (A).

MO4 Conduct interviews with victims, witnesses and suspects, demonstrating a

knowledge of the Police and Criminal Evidence Act and the principles of

Achieving Best Evidence (A).

Part 4: Assessment

Assessment strategy: Assessment task A:

3000-word assignment in which the learners will be required to critically assess both local and national domestic abuse guidance.

Rationale:

This will assess a candidate's ability to reflect on their practice, critically analyse what makes people vulnerable, and how the police can manage risk while conducting effective investigations.

Formative assessment will take place throughout the module through engagement with cohort and group discussion, questioning, mock exams and knowledge checks, and submission of witness statements which will receive written feedback.
