Teaching and learning methods: A variety of approaches will be used which may include:

Scenario based teaching through interaction

Digital learning and digital capabilities delivered through Blackboard and other virtual learning platforms

The learning approach for this module is based on a model of adult education.

Teaching strategies are used that value the students' previous learning and nursing experience, providing a forum for self-development and the development of practice.

The module will be structured primarily through facilitated seminars where there will be significant opportunities to share experience and learning.

Contact Hours: A total of 36 hours in the form of seminars, lectures and online activities.

Module Learning outcomes: On successful completion of this module students will achieve the following learning outcomes.

MO1 Critically examine the context of the Mental Capacity Act, including legal and ethical aspects, recognising how statutory and professional requirements affect practice and the provision of care.

MO3 Explore the relevant knowledge and interpersonal skills required to engage people with a range of communication methods, support decision-making, undertake capacity assessments and promote the rights of the assessed person.

MO4 Critically explore the issues around assessing capacity and Best Interest decision-making, considering the outcomes and actions that follow from the completed assessment.
