Part 2: Description

Overview: This elective module focuses on personal injury litigation and the specialist area of clinical negligence. It requires an extensive familiarity with civil procedures and rules.

Features: Not applicable

Educational aims: The critical understanding and application of personal injury and clinical negligence claims and the practicalities of advising clients in this area of the law.

Outline syllabus: Students will cover a variety of aspects to include, for example, liability within personal injury and clinical negligence claims, evaluating damages, understanding and interpreting medical records and consideration of some of the more common procedural features of personal injury and clinical negligence claims such as expert evidence.

Part 3: Teaching and learning methods

Teaching and learning methods: Workshops are interactive and are designed to allow students to hone the skills acquired to date on the Solicitors Training Course such as practical legal research, case analysis, writing and drafting and undertaking interviews, tailoring these skills specifically to personal injury and clinical negligence disputes whilst developing their knowledge of the rules and procedure.
