Students will consolidate evidence-based practice and research skills such as:

Advanced ability to appraise, analyse and synthesise knowledge from a range of sources and methodologies

Critically apply theoretical and philosophical perspectives in analysis and evaluation

Sound understanding of local/national/international priorities/policy

Sound digital literacy

Sound knowledge of quality improvement and change management

Outline syllabus: The module offers students the opportunity to pursue a topic of professional interest in depth and produce an extended piece of written work as a final year project. The project will offer a choice of options for students to demonstrate the generic learning outcomes for the module.

Part 3: Teaching and learning methods

Teaching and learning methods: In addition to learning through enquiries within the module students will have access to tutor led workshops, group and/or individual supervision with a supervisor (this process may include some input from others staff/practice colleagues with specialist knowledge), supporting skills workshops including library search sessions; critical reading and writing workshops.

Students will be supported by their project supervisors, module lead, and Academic Personal Tutors. Additional support can be accessed through the library, subject librarians and online resources.

Self-directed learning activities/workshops developed by the library for increasing information literacy, which include, sourcing and accessing information and evidence and critical writing skills will further support the teaching and learning for this module. Students will be encouraged to attend research and quality enhancement presentations/forums, within the university and other areas.

Part 4: Assessment

Assessment strategy: Overall, the project and portfolio will be a maximum of 6000 words and the student will be supported with academic supervision.

Formative assessment: students will have the opportunity to discuss their ideas and work with their academic supervisor and peers in regular group supervision sessions.

Supervisors will be granted access to the student's pebble pad progression document and reflections (which will form the basis for the summative assessment), and could give further feedback to the student's contributions to their online

progression documentation. This document will support reflection, planning and progression.

Students will be encouraged to identify and seek additional feedback on their ideas and work from practice/community/service users and research colleagues if they are supporting supervisory process.

Summative assessment: a project comprising a self-directed written assignment with an associated written portfolio.

Self directed written assignment - maximum 5000 words which demonstrates/presents the self-directed project

Portfolio - maximum 1000 word portfolio of evidence which supports the project (all pathways to undertake this).
