Stakeholder engagement and communication strategies
Assessing the public good or commercial viability of a project
Resource planning - people and process
Finance and sources of funding
Risk management strategies

Assessment strategy: Component A – Individual Digital Academic Presentation -15 Minutes (plus additional 10 minutes questioning) plus an additional supporting portfolio of evidence.

Selecting an appropriate project example (local, national, global) demonstrate your ability to disseminate and critically evaluate the business case in terms of its commercial or 'public good' viability. Ensure that your evaluation identifies and interprets financial information, assesses sources of funding and clearly identifies how stakeholder engagement and risk analysis can be used to effectively manage projects. Judgements should be underpinned by appropriate concepts and case study examples. The portfolio of evidence should be suitable for a business audience, it could include relevant research material and case studies examples that have contributed to the evaluation of the business case.
