Part 4: Assessment

Assessment strategy: Summative assessment of the module will be a reflective piece, considering two of the following, as they relate to a case study from clinical practice:

•Law

Ethics

Leadership

Students can choose to complete either:

A 2500 word reflective assignment

or

A 25 minute individual reflective professional conversation

Rationale: This assessment enables students to demonstrate the module learning outcomes as they apply to a case from their own clinical practice. It provides an opportunity to assess the student's ability to reflect upon the principles and relevant theory of law, ethics and leadership from their experiences within paramedic practice.

Formative assessment will take place through case reviews, tutorial support and reading by a personal tutor of draft work.
