Part 4: Assessment

Assessment strategy: Within this module you produce a Case study (1250 words). The case study will require you to review academic theory and apply it to your own practice within the context of organisations' internal environment. You will produce a piece of work that identifies the organisational behaviour of your own organisation, this will include; discussing leadership, communication and stakeholder influence. Formative assessment will occur throughout the module and will take the forms of mini seminars, verbal feedback and in class presentations.

Summative assessment takes place at the end of the module, and has one assessment task. You will identify an organisation of your choice and develop a report on how the theories discussed within the class are applied within your choice of organisation.
