### Part 4: Assessment

**Assessment strategy:** Task 1: The assessment for this module will be an investigative presentation (10 mins) that identifies the procurement practices that operate within an organisation of your choice.

Task 2: A 1500-word case study based around the procurement and contract processes within your organisation taking account of the potential implications of each. You should also discuss the potential procurement and contract management implications that can derive from various different sources of project funding.

Opportunities for formative assessment exist for each of the assessment strategies used. Verbal feedback is given and all students will have opportunity for personalised tutorials to discuss the application of their ideas.
