Part 2: Description

Overview: This module will explore the range of complex legal, political and social facets from which modern terrorism has emerged and of which it is comprised. The module has a socio-legal focus and will adopt a multi-disciplinary approach that draws upon criminological literature in this area (for example, with regard to the study of the processes of radicalisation), alongside a critical consideration of the relevant law in this field. Such an approach will enable students to engage in

Page 2 of 5 23 March 2023 nuanced analysis of the criminal justice response to the challenges of contemporary terrorism and will facilitate a recognition and understanding of the challenges faced by law enforcement, intelligence and government agencies. It will require students to engage in a continuing and detailed assessment of the nature and methodologies of terrorism, the counter-terrorism activities levelled against terrorist activity and the relevant law and justice responses.

Features: Not applicable

Educational aims: The educational aims are to facilitate the legal, social and political analysis of terrorism and counterterrorism. This includes an assessment of the relevant law, policy and other relevant academic perspectives that inform the study of the phenomena of modern terrorism. The module takes account of counter-terrorism policies and procedures (including relevant legislation such as the Terrorism Act), Human Rights approaches and criminological/socio-legal perspectives.

Outline syllabus: The indicative syllabus for this module includes: Conceptual analysis of terrorism (Socio-Legal) The law of counter-terrorism Terrorism and the media Far-right terrorism and extremism Comparative counter-terrorism law and policy Domestic counter-terrorism and the relationship between law and policy Terrorism and Human Rights law

Part 3: Teaching and learning methods

Teaching and learning methods: Face to face lectures, workshops, and drop in hours. The learning environment will be enhanced by a blackboard module page containing e-resources and a reading list to support independent study.
