Part 2: Description

Overview: This module will explore the historical development, dynamism and nuances of contemporary family law and the justice system to help students to develop their analytical, evaluative and critical skills.

Educational aims: The module aims to enable students to gain a critical understanding of the legal framework but also socio-legal aspects of the role of family law in contemporary society in England and Wales.

Outline syllabus: The indicative syllabus for this module includes:

The nature, meaning and role of the 'family' and of 'family law' in the 21st century Adult relationships, finance and the home in the context of: Intimate relationships, cohabitation, and matrimonial orders including non-marriage, presumption of marriage, forced marriage, nullity of marriage, judicial separation, divorce and dissolution Domestic abuse, violence and coercive control Capacity and death Children: Conception, surrogacy, parental responsibility Child arrangements, specific issue and prohibited steps orders; Child abduction State intervention: care, supervision, special guardianship, and adoption orders Dispute resolution, privacy and transparency Law reform.

Part 3: Teaching and learning methods

Teaching and learning methods: The learning on this module will take place through a variety of modes including directed independent learning, self-directed learning, and group activities. Students will need to adopt a proactive approach to the module and engage with the full offer of learning opportunities to ensure successful achievement of the learning outcomes.

Directed independent learning includes engaging with resources such as recorded lectures and reading as well as guided activities for example preparing notes, and case studies. Self-directed learning includes activities such as reading, note-taking,

research, and exploring resources. Group activities may include discussions, legal debate, collaborative working, and peer learning.
