Part 2: Description

Overview: The module will examine the well-established concepts and principles of public international law such as the sources and subjects of international law, jurisdiction, the peaceful settlement of international disputes and State responsibility. In the module, the law will be discussed and applied to a diverse range of situations.

in wider project work involving external engagement as well as personal and professional development activities.

Educational aims: The aim of this module is to provide students with an introduction to not only the concepts, principles and organisations that govern international relations but also the legal methods and theories used in international law.

The module is connected to the Student Lawyer Project, which will be delivered programmatically across the year. Students will engage in two project weeks, one in each teaching semester. Through the projects students will extend their academic studies into wider exploration of legal themes, external engagement, and ongoing reflection on their own personal and professional development with the aim of supporting their wider development across their individual student journey.

Part 3: Teaching and learning methods

Teaching and learning methods: The learning on this module will take place through a variety of modes including directed independent learning, self-directed learning, and group activities. Students will need to adopt a proactive approach to the module and engage with the full offer of learning opportunities to ensure successful achievement of the learning outcomes.

Directed independent learning includes engaging with resources such as lectorials and reading. Self-directed learning includes activities such as reading, note-taking, research, exploring resources and preparing for the workshops. Group activities may include discussions, legal debate, and peer learning.

The module is designed through the lectorials and workshops. Lectorials are

principally designed to communicate the major principles, rules, concepts relating to

public international law as well as to stimulate interest in the topic. Workshops will

assist in monitoring the acquisition of the knowledge and understanding of

international legal issues developed during the lectorials. Some of the workshops will

be specifically aimed at learning new or improving the students already acquired

legal skills, such as answering problem- and essay-questions.

Through the Student Lawyer Project students will engage in project work which will

further support their development of independent learning skills; research; team

work; time management; presentation skills and the capacity for effective reflection

on their learning.
