## Part 3: Teaching and learning methods

**Teaching and learning methods:** The module will consist of protected learner time to develop a practice-based project. Learners will be supported to develop their project by a project supervisor.

Throughout the module, learners are provided with opportunities for formative assessment and feedback, typically this includes activities in groups and independently, submission of portfolio draft and plans, model portfolio extracts uploaded to blackboard and discussion board with peers and module delivery team'.

**Module Learning outcomes:** On successful completion of this module students will achieve the following learning outcomes.

**MO1** Critically reflect on your skills, knowledge and behaviours in a specific area(s) of public health.

**MO2** Apply and communicate the principles of work-based learning and continuing professional development, and demonstrate appropriate reflective practice.

## Part 4: Assessment

**Assessment strategy:** Defended Presentation - 25 minutes total (made up of 15 minutes with 10 minutes of questions)

A work-based project will enable learners to document, discuss and reflect on their learning in practice. The learners will present the project via a poster presentation. The project will directly link to a specific piece of work in a specified area of public health, demonstrating how they have gathered and applied public health knowledge, skills and behaviours. They will also identify their learning needs and develop an action plan for future learning and career aspirations which will form part of the

Formative assessment will occur through each student being allocated a project supervisor. This assessment supports learners to build relevant skills in preparation for the End Point Assessment.
