Part 2: Description

Overview: This module is designed to enable experienced social workers to develop their evidence based decision making skills regarding the core elements of protection and risk in practice.

Features: Not applicable

Educational aims: This module aims to develop experienced social work practitioners' understanding of the theory and evidence base on decision-making regarding protection and risk and to support their development of criticality for complex and high risk situations.

Outline syllabus: This is a module is designed for social work post-qualifying continuing professional development.

This module will support students to explore theory, research and anti-oppressive approaches in relation to abuse and professional responses in relation to the prevention and management of risk and harm. Theories explored include psychosocial approaches to violence and abuse, positive risk-taking approaches, cultural aspects of abuse and risk and risk management approaches. The module will give opportunities for students to consider specific areas of abuse such as sexual abuse and signs and symptoms of abuse in children and adults. The teaching will encourage students to recognise protection and risk as interprofessional social, individual and family issues which often require multi-agency responses.

Professionals in health and social care are required to be accountable for and defend their decision making, and this module will enable students to think critically about how they balance protection, autonomy and rights in managing risk and harm.

Part 3: Teaching and learning methods

Teaching and learning methods: Teaching on this module includes whole group lectures and small group activities such as learning sets. Students will be expected to study independently with structured learning which could include guided reading, case studies etc. Teaching may be face to face, online or a mixture of these.

This module is taught and assessed at both level 6/3 and 7/M.

Formative feedback opportunities are provided to students throughout the module by the teaching staff and through peer led learning sets. Students will be asked to read and discuss specific journal articles which will form the basis for the assignment Module Specification

questions. They will receive feedback through this process on their developing understanding, knowledge and critical evaluation skills within a supportive context. Teaching staff will provide ongoing feedback on the appropriateness and level of student understanding and skills and offer support with study and critical thinking
