Part 2: Description

Overview: An autonomous and independent study, under the appropriate supervision of a member of staff appointed from within the Law School. The focus of the module is on the process and outcomes of independent research and investigation, and the development of legal research skills.

Features: Not applicable

Educational aims: In addition to the assessed Learning Outcomes the educational experience may explore, develop, and practise, the following:

Oral presentation, communications and negotiation skills through a supervision process;

time management skills;

effectiveness at working independently;

reflection on own learning;

use of appropriate IT and electronic data resource to aid efficient searching, communication and presentation of information.

Outline syllabus: Multiple workshops will be offered which will provide an introduction to the module, and outline the core skills through the module.

Part 3: Teaching and learning methods

Teaching and learning methods: The module will provide students the opportunity to integrate and apply the learning and skills acquired through the programme by writing a substantial piece of individual research which is relevant to practitioners and/or researchers in the field of law. This might involve the testing of hypotheses, developing theory, or the provision of logically supported practitioner recommendations. Students will be encouraged to use the full range of data sources and analysis tools provided for Law postgraduate students.

The project module is a spine module that runs over the full academic year.

The module focuses on developing students' understanding of research, identifying relevant and feasible research topics, formulating research questions, identifying the relevant literature and developing a literature review to inform the hypotheses. The module will further focus on teaching research methods.

Subsequently, the module focuses on the project and the student is supported by the research mentor to build a portfolio of evidence covering four areas: aims and objectives; a critical review of key literature; methodology and ethics; and legal

analysis. The research mentor provides guidance and feedback on the portfolio

submissions and acts as the immediate contact point when ideas need to be

explored or problems addressed.

The student will determine his or her own learning pattern. Each student will be

guided by a suitably qualified mentor. Once a student has been allocated a mentor,

they will agree upon a project type and topic with their mentor. There will then be

periodic contact with that mentor, during which time the student will report on the

development of the research proposal into a formal plan of research, the review of

legal research questions or legal research Law-Commission style report, the existing

literature and other information sources, legal analysis, and the development of

discussions and a conclusion (or recommendations).

Part 4: Assessment

Assessment strategy: Assessment Task 1 is a portfolio that is followed by a critical

discussion of 15 minutes which will assess the quality of the portfolio. The portfolio

will comprise the research proposal, their evaluation of the key literature in the

research area, identification and collection of relevant key legal issues and the key

research methodology which the student will then defend.

Assessment Task 2 is a 2,500 to 3,000 legal research essay or legal report which

will focus on the analysis of the key relevant legal issues, presenting and discussing

the key legal issues and findings, and arriving at conclusions and recommendations

for practice.
