#### Part 4: Assessment

**Assessment strategy:** In line with the Assistant Practitioner apprenticeship standard, there are two required assessment tasks:

Assessment Task1: Observation of practice with question and answer session. Total:

2 hours and 15 minutes, consisting of the following:

Live observation - 90 minutes

Question and answer session - 45 minutes

This assessment method is graded Fail/Pass.

Assessment Task2: Professional discussion underpinned by a portfolio of evidence -

90 minutes. The portfolio of evidence must be completed before gateway.

This assessment method is graded Fail/Pass/Distinction (at resit and retake this is capped at Pass).

Candidates must pass both assessment methods.

The grades for the assessment tasks combine in the following way, to give an overall grade for the module of Fail/Pass/Distinction\*:

[Format: Assessment method 1 + Assessment method 2 = Overall Grade]

Fail + Fail = Fail

Fail + Pass = Fail

Fail + Distinction = Fail

Pass + Fail = Fail

Pass + Pass = Pass

Pass + Distinction = Distinction

Rationale for Assessment Task1 - Observation of practice with question and answer session:

This is a practical role, best demonstrated through completing activities in a real

work setting

Observation makes use of employer resources and equipment, which will be familiar

to the apprentice and thus allow them to perform at their best

Questioning allows for the assessment of the breadth and depth of underpinning

knowledge against the grading descriptors in the apprenticeship standard

Tasks completed during the observation should contribute to workplace productivity

and are valid

It is a holistic assessment method.

Rationale for Assessment Task 2 - Professional discussion underpinned by a

portfolio of evidence:

This assessment method allows assessment of responses where there are a range

of potential answers that cannot be tested through the observation.

It allows for assessment of knowledge, skills and behaviours that do not occur on a

predictable or regular basis.

A professional discussion is a well-recognised method of checking knowledge, skills

and behaviours and is widely used within the health sector.
