Part 2: Description

Overview: This module explores the rationale behind the use of imprisonment as a form of criminal sanction and the impact of the European legalisation of human rights on its aims, its administration and execution in the UK and from a comparative angle.

Features: Use of real life European Court of Human Rights judgments on issues surrounding imprisonment

Educational aims: The objective of the module is to equip students with a critical understanding of prison as punishment and of the contribution of human rights to a more accountable administration of imprisonment, drawing on the legalisation of human rights in Europe.

the legalisation of human rights in Europe and in the UK
human rights and prisons
prison policy in England and Wales and in Europe
sociology of imprisonment
mentally disordered prisoners and therapeutic prisons

Teaching and learning methods: Students will learn through a combination of lectures, seminars, guest talks and audio-visual material prepared by official organisations. An online reading list and group student tutorials led by the module leader will support the student learning journey.

Report (weighted 50%)

A 2500-word evaluative prison report on a current prison issue that is drawn from the

UK or any other national prison system.

Plagiarism is designed out as each student can choose for themselves the particular

focus and context of the evaluative prison report. There is not a set number of topics

that students must choose from.

Written Assignment (weighted 50%)

A 2500-word critical review of a European Court of Human Rights (ECtHR) prison

related judgment. Students will be able to choose a ECtHR judgment out of a set

number of such judgments.
