Part 2: Description

This postgraduate Law programme offers students an opportunity to engage with the challenges posed by the current international trade regime in a legal context. It takes the perspective that international trade and economic law need to be considered along with the social, political and economic dimensions of governance and development. A range of trade and related issues are explored, such as the impact of international trade policy and rules on sustainability, development, human rights, competition and dispute settlement from the viewpoint of both developed and developing countries. The programme supports one of the key aims of UWE, in seeking to foster a strong global outlook in students. It is designed to encourage innovation and creativity in assessing current problems at the cutting edge of international trade and economic law and in designing responses thus preparing graduates for employment in legal practice and commercial organisations as well as the public sector and non-governmental organisations, both in the UK and abroad.

The programme is based on an understanding of law as both a vocational discipline and a subject of academic study. The programme seeks to reflect this by:

- Equipping students with an advanced understanding of international trade and economic law, especially focusing on current issues at the forefront of academic study.
- Developing the analytical skills needed to make reasoned, creative and original judgments regarding the development and practical application of the law in this area.
- Assisting students to develop greater intellectual autonomy and to become independent learners.
- Equipping students with the research skills and methodological knowledge needed to conduct advanced legal research.
- Refining students' ability to communicate effectively complex ideas in oral and written form.
- Developing students' ability to look reflectively at their own professional practice.
- Encouraging ethical decision-making, sustainability and global citizenship.
- Assisting students to develop the qualities and transferable skills necessary for employment requiring the exercise of initiative and personal responsibility and decision-making.
- Encouraging lifelong learning and personal development and thereby enabling students to be able to work with self-direction and originality and to make a positive contribution to society.

Programme requirements for the purposes of the Higher Education Achievement Record (HEAR)

The programme equips lawyers with the knowledge and skills necessary to engage with trade and businesses at the global level. As business have become global, lawyers who want to practice both in the international and domestic commercial and business sectors need an understanding of international trade to enable them to operate in this highly complex and competitive area. Students completing the course will have a critical and contextual understanding of the processes, actors and institutions of world trade and the free flow of capital, goods and services that shapes today's global economy. Graduates will be equipped with both the subject expertise as well as a range of professional and transferable skills which are sought after in commercial legal practice as well as in business, and the public and voluntary sectors, both in the UK and internationally.

Part 5: Entry Requirements

Candidates should normally hold a good honours degree in law (LLB (Hons)) or equivalent from a recognised UK Higher Education institution or equivalent from a recognised overseas institution. Non law graduates may be admitted if they have relevant experience.

Applicants whose first language is not English will be required to demonstrate appropriate English language proficiency, by having either:

- A minimum grade of 6.5 overall on the British Council International English Language Test (IELTS), with at least 5.5 in each component of the test.
- A TOEFL score of at least 90 (internet based test) with at least 21 in listening, 22 in reading, 23 in speaking and 21 in writing.
