# Section 2: Programme Overview, Aims and Learning Outcomes

### Part A: Programme Overview, Aims and Learning Outcomes

**Overview:** The foundation year of study consists of four year-long 30 credit modules in which the main focus is on the acquisition both of appropriate academic skills and of an awareness of the relevance to their future professional lives of the disciplines of law, economics, accounting and business and management. Becoming A Professional (UJUUL9-30-0) will act as a "spine" to the year, supporting the other three modules through a reflective portfolio and three integrative project weeks. Students will be encouraged to develop as reflective learners and to understand the importance of the UWE graduate attributes. This provides a solid foundation in business for students to progress into their business related degree specialism.

Team Entrepreneurship is an enterprise and entrepreneurship programme which helps you develop the behaviours, attributes and competencies you need develop a successful business career. You will engage in topics within the fields of enterprise and entrepreneurship.

If you want a practical course that enables you to "learn by doing", then Team Entrepreneurship could be for you. It is an innovative, practice-based degree which allows you to take control of your own learning so that you can graduate ready-andable for your chosen career. You will be a part of a learning community that will help you develop what you need to become an effective team player, capable of supporting, developing and creating the value-generating ventures of the future.

The course is recognised as a model for practice-led, self-managed, team-based, enterprise-orientated learning. By engaging in the complexities of organisational life, you will be gain rich opportunities for learning and self-development. "Team Academy" principles are applied, which were developed in Finland in the 1990s, and now adopted in many universities across the UK, Europe and beyond. These include:

- Not students But team entrepreneurs
- Not classrooms But an open plan office
- Not teaching But learning
- Not teachers But coaches
- Not simulations But real ventures
- Not control But self-organising

You will undertake your learning journey as part of a "Team Company", which will be your primary environment for managing and sharing your learning throughout the course. You and your Team Company will be supported by a "Team Coach" – a member of staff who will support and challenge you throughout your learning journey, helping you every step of the way.

You will develop your own "Learning Contract" where you set out where you want to get to and how you will get there – this will be reviewed and agreed with your Team Company and become the primary tool for setting goals and monitoring your achievements.

Throughout the course you will engage in a wide range of self-directed learning activities that will enable you to develop core enterprising and entrepreneurial competencies. These will give you the knowledge, skills and confidence you need to develop yourself, to work with others and to create, develop and manage your own business ventures. You will "learn by doing", working with others in your own projects and ventures. You will carry out your own enquiries into topics that enable you to gain the knowledge and understanding you need to achieve your goals.

In addition to the other members of your Team Company and your Team Coach, you be expected to develop your network by making links with, for example, local businesses, mentors, previous graduates and Team Entrepreneurs from other Team Academies in the UK and abroad. This will enable you to build a rich network supports you during the course and can stay with you after you graduate.

As you engage in all aspects of the course, you will gather evidence of your learning and development which you will use to show your Team Company and your Team
