Part 2: Description

Overview: This module enhances students' confidence in effective management of their own creative direction through sharing their artwork with audiences. Students are involved in group activities where they build skills and ambition through making and presenting artworks. They are supported to navigate this process using appropriate research methods, reflective analysis and creative techniques.

Features: Not applicable

Educational aims: The aims of this module are to develop students' confidence and proficiency as practitioners, as they shift into a self-generated and managed art practice. Students will consider and experience the relevance and impact of public outcomes. Through sharing their making in group activities, they will develop skills in critical analysis both of their own work and that of others. Students will enhance their ability to communicate effectively, conveying ideas and information clearly and persuasively through diverse mediums, adapting to different audiences and purposes.

Outline syllabus: During the module, students will develop their artwork and consider ways of showing through independent activity and teaching sessions including workshops, tutorials and seminars. They will be exposed to group opportunities that facilitate the experience of sharing and presenting artwork. Students will document their practical and research processes as a reflective tool and research aid. Teaching sessions will provide forums for critical reflection and contextual analysis.

Indicative content:

Module sessions and resources support and 'scaffold' students to develop their individual creative ideas and make new work.

Module sessions enhance students' understanding of how display and presentation supports the communication of ideas.

Students are supported to communicate effectively and critically analyse their own work and that of others through teaching sessions.

Students will be supported to manage their personal practice working safely, ethically and responsibly.

Students will be provided with a range of technical support relevant to their module learning.

Towards the end of the module, students will have the opportunity to install and exhibit work in a supported group exhibition.

Part 3: Teaching and learning methods

Teaching and learning methods: It is through experimentation with media that students are expected to develop and produce a body of work that explores the practical, theoretical and technical aspects of their individual areas of interest within fine art.

Students are able to undertake workshop activity in order to examine the dialogue between form and content within their work, and fulfil module learning outcomes.

Teaching and learning activities are designed to develop an understanding of a range of research methods and approaches to professional activity, including issues pertaining to the wider context of making, exhibiting and communicating ideas effectively. Students are encouraged to consider different working methods and media and consequently reflect on their own approaches and outputs in their own work.

Seminar activities and one-to-one tutorials focus on developing personal methodologies and organisational skills, critical feedback and monitoring the ongoing progression of work.

Group sessions are used as a method to increase confidence and understanding and allow individuals to begin to develop organisational, editing and presentation skills. Peer and self-assessment are utilised as a means of developing both a greater understanding of assessment as an approach to learning and the role of critical reflection in the development of practice.
