## Part 2: Description

**Overview:** Public law is in action around us every day. We see it in the news, and we hear others talk about it on current affairs programmes or on social media. However, law students possess a detailed knowledge of the theories, rules, and laws that operate in the field of public law which makes them able to comprehend what occurs behind the media stories and, often, helps them identify inaccuracies. At its heart, public law concerns the states powers and the relationship between the state and the individual. What can Parliament, Government, or the Judiciary do and what

happens when one of those bodies acts beyond its powers. This module introduces students to the main legal and political institutions of the UK, and it considers their roles in the UK's unwritten constitution. It also introduces students to the relationship between the individual and the state and the rules and laws that govern that relationship. The module is split into two parts: first, we will look at the foundation of the UK constitution. All elements of the state and all other laws are built upon this, so it is fundamental aspect to our study of the law. The second part of this module will introduce you to judicial review and human rights.

The module will be delivered as a separate module, but presented programmatically together with Criminal Law as Public Law.

It will be linked to the Student Lawyer Project, where students will engage in wider project work involving external engagement as well as personal and professional development activities.

**Educational aims:** The emphasis throughout will be on providing the student the opportunity and facilities to find, understand, apply and analyse the law in its historical, practical, academic and social contexts.

The module is connected to the Student Lawyer Project, which will be delivered programmatically across the year. Through projects students will extend their academic studies into wider exploration of legal themes, external engagement, and ongoing reflection on their own personal and professional development with the aim of supporting their wider development across their individual student journey.

**Outline syllabus:** The following is indicative content, not all topics will necessarily be covered, and the content may vary over time as current medico-legal issues develop.

The course comprises a mix of law and legal theory and the following list is an indicative list of topics which the module will include:

- oAn introduction to the United Kingdom's constitution
- oThe separation of powers

- oThe rule of law
- oParliamentary supremacy
- oAn introduction to judicial review
- oAn introduction to human rights

### **Part 3: Teaching and learning methods**

**Teaching and learning methods:** The emphasis for this module is to provide students with the opportunity to gain knowledge and understanding while also applying, and analysing the law and legal theory.

The learning context is student-centred and utilizes a variety of techniques to encourage independent thought and constructive and analytical criticism. Dialogue is promoted between student and lecturer in an inter-active relationship that emphasizes the two-way flow of information and critique.

Scheduled learning includes in-class taught sessions that are based on and build further independent learning such as engagement with essential reading, assignment preparation and completion etc.

Through the Student Lawyer Project students will engage in project work which will further support their development of independent learning skills; research; team-work; time management; presentation skills and the capacity for effective reflection on their learning.

## **Part 4: Assessment**

**Assessment strategy:** The assessments have been designed to complement the assessments in the Criminal Law module.

A combination of written and oral assessment has been chosen.

Essay: approx 2000 words, with scope for variation based on prompt set (60%) . This written assessment tests academic rigour, argumentation, application of fundamental rules and concepts in Public Law, and legal analysis.

Presentation ( 40% ). Recorded oral presentation to test the ability to research the law, apply it, and present findings in a structured environment; supported by a short written supplement.

A proportion of this module's mark will come from the Student Lawyer Project.
