## **Part 2: Description**

**Overview:** The module will examine the fundamental principles of criminal law, with a focus on the inter-relationship of statute and case law, encompassing offences and defences.

The module will be delivered as a separate module, but presented programmatically together with Public Law as Public Law.

It will be linked to the Student Lawyer Project, where students will engage in project work involving external engagement as well as personal and professional development activities...

Educational aims: The module will examine the fundamental principles of criminal law, with a focus on the inter-relationship of statute and case law, encompassing offences and defences, with application of the law to a diverse range of practical situations developing the skills of research, critical analysis, evaluation and application.

The module has been designed to complement the Public Law module. The two modules, whilst separate, will be taught as different aspects of Public Law, reflecting the programmatic approach to delivery within the programme.

The module is connected to the Student Lawyer Project, which will be delivered programmatically across the year. Through projects students will extend their academic studies into wider exploration of legal themes, external engagement, and ongoing reflection on their own personal and professional development with the aim of supporting their wider development across their individual student journey.

**Outline syllabus:** The indicative syllabus for this module includes:

- •An introduction to the criminal law and the criminal justice system
- •The elements of a crime
- •The nature of actus reus, omissions and causation
- •The nature of mens rea and notions of culpability
- Offences against the person
- Property and dishonesty offences
- Inchoate offences
- Parties to a crime
- Capacity
- Defences

## Part 3: Teaching and learning methods

**Teaching and learning methods:** The learning on this module will take place through a variety of modes including directed independent learning, self-directed learning, and group activities. Students will need to adopt a proactive approach to the module and engage with the full offer of learning opportunities to ensure successful achievement of the learning outcomes.

Directed independent learning includes engaging with resources such as recorded lectures, Blackboard self-assessment tests, Mentimeter, videos and reading as well as guided activities for example preparing notes, case studies and worksheets. Self-directed learning includes activities such as reading, note-taking, research, and exploring resources. There is also an expectation that students will self-assess their own learning needs and make use of the additional support available via the Learning Hub. Group activities may include discussions, legal debate, collaborative working, and peer learning.

The group activities and directed learning form an essential part in providing students with the knowledge and skills required on the criminal law module. The module has been carefully designed to ensure that students are fully supported on their journey through this transition year, in order to achieve successful completion of the module.

Through the Student Lawyer Project students will engage in project work which will further support their development of independent learning skills; research; team work; time management; presentation skills and the capacity for effective reflection on their learning.
