Part 2: Description

Overview: The module is inspired by the Street Law movement which has supported the delivery of public legal education across the world since the 1970s. This module offers students opportunity to enhance a range of academic and professional skills through delivery of projects relating to legal topics created and disseminated to public audiences.

It will provide opportunity for further enhancement of skills which students will have developed through the Student Lawyer projects embedded in Levels 4 and 5.

Features: Not applicable

Educational aims: The aim of the module is to enable students to develop practical and academic skills in the context of creating and delivering projects relating to legal issues which are of relevance for dissemination to a range of public audiences. It draws on the philosophy of the global Street Law movement which supports delivery of public legal education in a variety of forms.

Outline syllabus: The module syllabus will be skills based. It will involve working with different areas of law, which will be selected depending upon the projects chosen by the students for each module run. Students will use the focus of each Street Law project to develop a range of skills, including practical and academic legal research; collaborative group working; communication in different forms for different audiences; project management; time management; effective presentation skills and critical reflection.

Part 3: Teaching and learning methods

Teaching and learning methods: The module will be delivered through student led workshop sessions. Students will be supported by lecturers to take control of their learning and to determine the subject, format and public audience for each project.

Module Learning outcomes: On successful completion of this module students will achieve the following learning outcomes.

MO1 Conduct self-directed research, evidencing capacity to identify, retrieve and critically evaluate relevant information from a range of primary and secondary legal and contemporary sources.
