Part 2: Description

Overview: This course offers a comprehensive exploration of questions related to development, trade and migration. From historical perspectives to modern theories, students will examine the causes and consequences of trade and migration, and delve into theories and practices aimed at understanding economic growth, poverty alleviation and human development in developing economies. By the end of this module, students will develop a comprehensive understanding of the dynamics of development, trade and migration, and be equipped with analytical tools and critical

perspectives to navigate the complexities of global economic systems in the 21st century.

Educational aims: The module aims at providing students with a deep understanding of the intricacies surrounding development, trade and migration. Through a blend of historical context and contemporary theories, students will explore the drivers and impacts of these phenomena, while also gaining insight into strategies for fostering economic growth, reducing poverty and promoting human development in developing economies. Students will develop an understanding of how the global context shapes the dynamics of development, trade and migration, as well as an awareness of reliable data sources on development, trade and migration.

Teaching and learning methods: Lectures will sometimes be driven by theory, sometimes by current events but always connecting the theory to reality in order to provide students with tools to analyse economic problems.

Seminars will take a variety of forms, and students may be asked to present to the class their answers to questions and problems which will be provided during the year. These seminars will aim to develop student's analytical ability and problemsolving skills.
